# **MISSION:**

The mission of the Berks Business Education Coalition is to develop and to coordinate programs within the business and education communities which improve the competencies of students and ensure that they have the aspirations, skills, and knowledge to plan appropriately for their lives after high school.

Collaboration. The Berks Business Education Coalition (BBEC) is all about collaboration. We are a coalition within and between the business and education communities, doing our part, to promote the growth, maturation, knowledge, skill set, and aspirations that enable students to become successful contributors to an increasingly complex society. Through our mission statement and the goals we annually set, we work purposefully to these ends.

In this Annual Report, you will read about Career Ready Berks, the Berks County-wide initiative to promote resources for schools to draw upon when providing K-12 career awareness programs. We will tell you about *What's So Cool About Manufacturing* and the World Affairs Council of Greater Reading engagement with the schools. We also continue to promote quality Pre-K education for all students who then benefit from a focused early head start.

We value the positive synergy which results when business and education join together in the ways described above. Everyone benefits when students and the community come together to make Berks County a better place to live and work.

## **Career Ready Berks Guides the Way**

Baby boomers are retiring en masse, and the employment pipeline does not have enough skilled workers to fill the void. According to the Berks County Workforce Development Board, between 2011 and 2025, the potential retiree population, those ages 65-plus, is projected to grow about 45 percent, from approximately 60,000 to more than 88,000, or from approximately 1 out of 7 Berks County residents to nearly 1 out of 5. This, along with rising college debt and many "under-employed" college graduates have been headlining in the news lately.

Educators have heard the news from businesses and are reacting. Stakeholders from across Berks County have come together to form the Career Ready Berks **Alliance**. Career Ready Berks Alliance is a coalition of the 18 school districts in Berks County, the Career and Technical Centers, and local business and industry with the support of the Greater Reading Chamber Alliance and Northeast Chamber of Commerce, the Berks Business Education Coalition, and the Berks County Workforce Development Board. Together, this Alliance is working to provide equity and access to career awareness and exploration opportunities for the 70,000 students in Berks County. Bringing business and industry together with K-12 education, the Alliance believes will help students to explore career opportunities and make more informed decisions about their future. The experiences will also help to keep our talented youth here and help fill the need for a skilled workforce in the county. The Alliance believes career development equals workforce development which equals economic development for Berks County.

To help bring educators and businesses together, the Career Ready Berks Business Engagement Platform

has been developed. This online tool, available at careerreadyberks.org, is a digital platform for business and education to connect. Businesses can list the experiences they are able to offer to students, anything from career day speakers and field trips to job shadowing and semester internship opportunities. Students, parents, and teachers can search the platform for experiences and sign up directly online.

Workplace experiences benefit students in multiple ways. These experiences give students an early look into the workplace and help them make decisions for their future. They also allow students to develop and practice employability skills, essential for their future success. Additionally, workplace experiences open students' eyes to the opportunities right here in Berks County. Students get to see firsthand the thriving businesses that are growing and developing right in

their backyards. The benefit to business is also very important. Opening a business to students allows the participants to be a part of the future of Berks County. The workforce pipeline can be filled if we work together to educate our students on the opportunities available to them for promising careers right here. Bringing a student into your business allows an employer to build their workforce from the ground up, train the students, and integrate them into the industry.

Working together, we can provide equitable access to career information and experiences to the students of Berks County. The future workforce is in good hands with the Career Ready Berks Alliance guiding the way.

# **Berks County School District Senior Year Internships**


The concept of offering interested students a senior year internship experience is gaining greater and greater traction among Berks County school districts. Students typically spend two hours a day, five days a week for the semester or year, earning academic credit at a business site or internally in the school, investigating possible areas of career interest.

Sixteen of the 18 Berks county public school districts included the internship as an elective component in the senior year curriculum in 2018/2019 and 2019/2020. Five hundred sixty-eight (568) seniors chose an internship placement as part of their senior year curriculum the first semester, 2019/2020, representing 11.2% of the senior year cohort across the county. This number will grow as additional students select a placement second semester, spring 2020.

### **Scott Henderson** TWIN VALLEY HS

Scott Henderson, Twin Valley senior, has an internship placement with Morgan Corporation in Human Resources. Morgan is the largest manufacturer of light and medium truck bodies in the nation.

Part of his internship finds Scott assisting in the hiring process of prospective employees. Fatisha Quainoo, Scott's mentor, states that he has "increased Morgan's social media response rate by 60%" during his time there first semester. Scott believes that his experience has helped him focus his plans for college, pursuing study in either human resources or accounting.

# **Students Interacting with Business**

The Students Interacting with Business program exemplifies the commitment Berks County businesses have to education. During September, October, November, and December, 35 businesses hosted some 4,300 Berks County ninth graders in groups of 40 or 80 for a "boots on the ground" experience at a business, learning about a specific business, career

and employment opportunities, and most importantly, about the soft skills employers look for and value in an employee.

Intentionally, the program is held early in the high school years, providing information and perspective as the students plan for the important middle years of high school. Since 2013, Berks County businesses have hosted over 26,000 students through this program.



# Regional Berks-Schuylkill Construction Pre-Apprenticeship Program

The Hamburg Area School District has begun a pre-apprenticeship program for construction in conjunction with the Keystone Chapter of the Associated Builders and Contractors (ABC). The program focuses on students entering their senior year of high school who want to experience the construction industry for a possible career after high school.

Thirteen students from school districts along the I-78 corridor enrolled in fall 2019 with plans to continue into the second semester of 2020. The program provides students practical training across the spectrum of the construction industry, with the intent to make them attractive candidates for employment upon the completion of their senior vear and graduation.

A record number of educators participated in the 2019 insideBERKSbusiness (iBb) program this summer. In conjunction with the Berks County Intermediate Unit (BCIU), the Berks Business Education Coalition (BBEC) placed 30 teachers at 23 businesses and organizations around Berks County during the five-day internship. The program – a partnership between the BBEC, BCIU, and Berks County school districts – is designed to expose educators to career pathways available to their students after graduation, allowing them to better prepare students for the modern workplace.

The iBb program culminated on Thursday, August 8, with a tour of the Boscov's Distribution Center in Exeter Township. **Deputy Executive Secretary Robert O'Brien** from the Pennsylvania Department of Labor & Industry was in attendance and spoke of the importance of connecting education and business to build and maintain Pennsylvania's workforce.

Following the tour, the educators and business partners attended an appreciation and recognition reception to mark the completion of the 2019 program.

## **World Affairs Council** of Greater Reading **Outreach**

The World Affairs Council of Greater Reading (WAC) holds monthly luncheon and breakfast programs with speakers on topics relevant to international affairs. Program attendance is open to high school and college students at a significantly reduced rate. During the 2018/2019 program year, students and faculty chaperones constituted just over 50% of the total audience participation.

Luncheon and breakfast topics have included U.S. Immigration Policy, Negotiations with North Korea, Cuba at a Crossroads, and Vaccination and Global Health. German Counsel General David Gill presented in June about, "The Transatlantic Relationship in an Era of Great Competition."

# Higher Education Campus Visits

The Higher Education Campus Visits program brings students, primarily ninth graders, onto the campuses of Albright College, Alvernia University, Kutztown University, Penn State Berks, and the Reading Area Community College. For most it is their first time setting foot on a college campus and for some it will be the only time.

The students learn about a particular institution and participate in a campus tour. The broader message is the same for all, the culture and expectations that are common to every post-secondary education pursuit.

Through the now 16th year of the program, more than 34,000 students have participated, gaining insight and perspective as they traverse through their high school years.

The Manufacturing Resource Center (MRC) serves the needs of manufacturing-based businesses in Lehigh, Berks and Schuylkill Counties. As a part of its mission, MRC has directed student awareness of career opportunities in manufacturing over the past seven years through the innovative, "What's So Cool About Manufacturing" program.


Teams of middle school students go into a participating manufacturing facility to interview and film for three hours. The team then edits the work into a three-minute video with lots of expert guidance and critique to assist them. Everything culminates in a "big splash" awards night in March with hundreds of people in attendance.

Now in year four in Berks County, each of the 24 public middle schools have participated in 2019 matched equally with 24 businesses. Amid lots of interest, support, and excitement, awards night is scheduled for March 3, 2020.


